## **1** Introduction

### 1.1 Background

- 1.1.1 Gujarat Knowledge Society (referred as GKS or the "Authority") was established by the State Government of Gujarat with the primary goal to empower youth with the knowledge and skills needed to access better employment opportunities in today's knowledge-based economy. GKS comes within the administrative framework of the Commissionerate of Technical Education (CTE), under which various engineering colleges are operated in various regions of the State of Gujarat.
- 1.1.2 GKS intends to create 14 Centres of Excellence (CoEs) in 8 separate sectors, as per the details below, by leveraging its available grant with participation of private sector players (Industry Partners) for design, install equipment, maintain and operate it for the period of 5 years.

- 1.1.3 With this background, GKS invites expression of interest from interested parties to evaluate the interest and to validate the concept. GKS would come out with the detailed Request for Proposal (RFP) documents subsequently for appointment of Industry Partners.
- 1.1.4 After receipt of EoIs from private players, the Authority reserves the right to restrict the participation of the shortlisted Industry Partners in the subsequent RFP stage.
- 1.1.5 The Industry Partners may submit the EoI as a single Industry Partner or in consortium. The Industry Partners shall show their interest in development of one or more CoE in their EoI. For each CoE separate EoI must be submitted in separate sealed envelope.
- 1.1.6 During the RFP stage, the Authority would undertake the selection of preferred Industry Partners with a weighted total score of both the Technical Strength and Financial Proposal.
- 1.1.7 The Technical Strength would be evaluated based on the multiple parameters, which will be specified in the RFP stage, such as:
  - a. Experience in the Sector
  - b. Profile & brand of the Player
  - c. Experience of operating similar CoE or R&D Lab/ Center
  - d. Innovative concept/ proposal for creation of these CoEs
  - e. Financial strength in terms of turnover in the similar sector and net worth
  - f. Commitment in terms of investment and recruitment of students of CoEs
- 1.1.8 The Financial Proposal would be evaluated based on the either or certain combination of parameters, which will be specified in the RFP stage, such as:
  - a. Amount of capital/ operating investment proposed
  - b. Amount of capital/ operating grant quoted

## 2 Objectives and Roles

### 2.1 **Objectives**

With the objective of creating unique and the State-of-the-art research and innovation infrastructure in the upcoming sectors and with intention to promote academia – industry linkage, this concept of developing CoEs on PPP mode is proposed.

The main objectives of the CoE are as follows:

- 1. To develop the CoE with various machines and equipment as required for having a wellestablished CoE in a particular sector, certain minimum requirement of types of equipment and facilities would be defined in the RFP.
- 2. To promote industry relevant research and promote training and provide ecosystem to the students of the engineering colleges.
- 3. To promote academia industry linkage for promoting innovation among the students

### 2.2 Role of the Parties

The roles and responsibilities of the Industry Partner will be finalized in the RFP stage in consultation with the parties which have submitted the EoI. For easy coordination, an Institute Management Committee (IMC), shall be constituted in each CoE. The roles and responsibility of IMC will be decided at later stages.

However, the indicative roles of the parties are as below:

#### A. Role of Industry Partner:

- 2.2.1 The Industry Partners shall create the CoE as per the specifications, as specified in the Proposal and agreed, within the period of 6 months from the date of work order received from GKS.
- 2.2.2 The Industry Partners shall maintain and operate the CoE for the period of five years, which may be extended for another five years as per mutually acceptable conditions.
- 2.2.3 The Industry Partners shall conduct industry relevant courses/ research, involving students of the engineering colleges, in consultation with the IMC.
- 2.2.4 The Industry Partners shall grant the admission the students as per the framework approved by the College/ IMC
- 2.2.5 The Industry Partners shall undertake placement activities for providing employment opportunities for the students participating in these CoEs.

#### **B. Role of Engineering College/ State Government:**

- 2.2.6 The administrative control of the building housing the CoE shall remain with the College.
- 2.2.7 The State Government shall ensure provision of capital/ operating funds as per the agreed financial proposal. (As per Table:1, Page number 2)
- 2.2.8 The colleges continue to regulate admissions and fees except certain percentage of the admissions in the CoE which are allowed to be determined by the Institute Management Committee (IMC).

## 3 Scope of Work

- 3.1 Establishment of fully functional Center of Excellence with all the equipment and facilities.
- 3.2 Research and Development: Conduct cutting-edge research to advance the state-of-the-art in all the mentioned sectors exploring new algorithms, models, and applications.
- 3.3 Innovation Hub: Serve as a hub for fostering innovation by encouraging collaboration among researchers, academics, industry professionals, and startups.
- 3.4 Technology Transfer: Facilitate the transfer of technologies and knowledge from research labs to practical applications in industry.
- 3.5 Training and Education: Provide training programs and workshops to develop and enhance the skills of professionals and students in technologies and sectors, ensuring a well-trained workforce.
- 3.6 Industry Collaboration: Establish partnerships with industry players to understand real-world challenges and co-create solutions that have practical applications.
- 3.7 Best Practices and Standards: Define and promote best practices and standards in respective sectors, ensuring ethical considerations, fairness, transparency, and responsible AI usage.
- 3.8 Infrastructure and Tools: Develop and maintain state-of-the-art computing infrastructure and tools necessary for research and development.
- 3.9 Cross-disciplinary Collaboration: Encourage collaboration between researchers and experts from other disciplines (e.g., biology, physics, social sciences) to explore interdisciplinary applications and insights.
- 3.10 Policy and Ethics Advocacy: Contribute to the development of policies and ethical guidelines related to the responsible use of technologies, addressing issues such as privacy, bias, and security.
- 3.11 Placement and employment opportunities: Assist and guide the students for the placement and employment opportunities within the partner's organization and other industries.

## 4 General Instruction of Eol

- 4.1.1 The Industry Partners must submit separate proposal for respective sector and respective college/university separately in sealed envelope.
- 4.1.2 The EoI shall be submitted as per the formats, along with all supporting documents, provided in this Request for EoI (REoI) and seal it in an envelope and mark the envelope as "EoI for development of Centres of Excellence (Sector-\_\_\_) in Engineering Colleges (Name and location of the college) of Gujarat on PPP basis".
- 4.1.3 The EoI shall comprise a single package containing two separate envelopes, marked as "ORIGINAL" and "COPY" each containing original and copy of the EoI.
- 4.1.4 Eols submitted by fax, telex, telegram, or e-mail shall not be entertained and shall be rejected.

- 4.1.6 Applications should be submitted before 5.00PM on 14/02/2024 (the "Application Due Date") through RPAD speed Post or Courier or hand delivery.
- 4.1.7 The Authority may, in exceptional circumstances, and at its sole discretion, extend the Application Due Date by issuing an Addendum uniformly for all Applicants.
- 4.1.8 The EoIs shall be valid for a period of not less than 180 (one hundred and eighty) days from the date of the publication of this REoI. The validity of EoIs may be extended by mutual consent of the respective applicants and the Authority.
- 4.1.9 The EoI and subsequent RFP (either or together termed as the "bidding Process") shall be governed by, and construed in accordance with, the **laws of India and the Courts at Gandhinagar/ Ahmedabad** shall have exclusive jurisdiction over all disputes arising under, pursuant to and/ or in connection with the Bidding Process.
- 4.1.10 The Authority, in its sole discretion and without incurring any obligation or liability, reserves the right, at any time, to:
  - (a) suspend and/ or cancel the Bidding Process and/ or amend and/ or supplement the Bidding Process or modify the dates or other terms and conditions relating thereto.
  - (b) consult with any Applicant in order to receive clarification or further information.
  - (c) pre-qualify or not to pre-qualify any Applicant and/ or to consult with any Applicant in order to receive clarification or further information.

- (d) retain any information and/ or evidence submitted to the Authority by, on behalf of, and/ or in relation to any Applicant; and/ or
- (e) independently verify, disqualify, reject and/ or accept any and all submissions or other information and/ or evidence submitted by or on behalf of any Applicant.
- 4.1.11 It shall be deemed that by submitting the Application, the Applicant agrees and releases the Authority, its employees, agents and advisers, irrevocably, unconditionally, fully and finally from any and all liability for claims, losses, damages, costs, expenses or liabilities in any way related to or arising from the exercise of any rights and/ or performance of any obligations hereunder, pursuant hereto and/ or in connection herewith and waives any and all rights and/ or claims it may have in this respect, whether actual or contingent, whether present or future.

## 5 Eligibility Criteria:

5.1		The Industry Partner should be in the business of concerned sector of the CoE for at least 02 years as on 31 <sup>st</sup> December 2023.
5.2		The Industry Partner could be an industry or a public or private Academic institution, research Centre, think tanks, Foundations, Non-Profit bodies, multilateral or bilateral agencies, aid agencies, operating in the space of Education, Technology, Research, Curriculum development, Innovation in Education, development initiatives or similar areas. The Industry Partner could have headquarters in India or abroad.
5.3		Industry Partner should be able to demonstrate their experience in the specified areas by submitting:
	i	Details of projects undertaken in the education sector. The details should give a year wise break up of number of projects done, impact achieved, budget utilised and number of students/teachers/beneficiaries targeted along with brief details of the various projects.
	ii	Details of previous partnerships. The details should include Name of partner, Contact details, Nature of partnership, Project Outcomes, any other relevant information.
	iii	Documented Success Stories
	iv	3rd Party Evaluations/Reports/Research Paper Published
5.4		The Industry Partner must not have been declared insolvent/ bankrupt or should not have filed for insolvency/ bankruptcy or in the process of being declared bankrupt before any designated authority.
5.5		The Industry Partner should not have been blacklisted by any of the State/Central Government or organizations of the State/Central Government in India in the past three years.
5.7		The Industry Partner should have valid Registration Certificate, Service Tax Registration Certificate or PAN. Documentary evidence of any of the above must be submitted.
